

2020 CATHEDRAL CAMP BUS ROUTES

Supervision will be provided on every bus. Campers and parents must be at their pick-up points 10 minutes before the assigned time. If you are not at the drop-off location on time, the bus company will call the camp and we, in turn, will call you. If you (or a designated pick-up person) do not then arrive promptly, the bus will proceed to finish its route and the child will be returned to camp, and it will be your responsibility to get him or her home.

If you foresee that you or another responsible adult cannot be at the drop-off point on time, please call the camp (508-763-8874), so that the bus driver can be notified by radio. Since this procedure is a serious inconvenience to all concerned, you will be assessed an additional charge should this occur, so please be on time to meet your child.

Once a bus route is chosen, no changes are allowed during the session. Also children cannot eat on the bus because of the possibility of choking due to frequent stops and turns of the bus.

**Note: All church, school, and store bus stops are in parking lots.
Buses leave camp at 3:45 p.m.
